



TRANSPORTATION COALITION HIGHLIGHTS TDOT PROJECTS BACKLOG

NASHVILLE, Tenn. (March 17, 2015) – The Tennessee Department of Transportation has released a list of its backlogged, unfunded projects that exceeds \$6 billion and impacts most of Tennessee’s counties.

The list clearly shows the need for additional revenues to keep Tennessee’s transportation infrastructure strong, says an official with the Transportation Coalition of Tennessee.

“Without additional revenue, these unfunded projects will be substantially delayed for years or may never be undertaken or completed,” said Susie Alcorn, executive director of the Tennessee Infrastructure Alliance.

“These projects are desperately needed to maintain our existing transportation infrastructure and show how serious the problem is today,” Alcorn said. “These projects are in jeopardy when TDOT is in a maintenance-only situation.”

Notable upper east Tennessee projects in and surrounding Bristol, Johnson City and Kingsport include:

- SR-91 (from SR-67 [US-321] to SR-37 [US-19E]) [Carter County]: \$17 million
- SR-34/Greeneville Bypass (US-11E, west of Greeneville, to US-11E, east of Greeneville) [Greene County]: \$24.2 million
- SR-35/US-321 (Cocke County line to north of Nolichucky River [Bright Hope Road]) [Greene County]: \$23.5 million
- SR-35/US-321 (north of Nolichucky River [Bright Hope Road] to east of Pate Road) [Greene County]: \$28.7 million
- SR-35/US-321 (east of Pate Road to SR-34 [US-11E]) [Greene County]: \$29 million
- SR-31 (Mooresburg to Adams Lane) [Hawkins County]: \$2.8 million
- SR-66 (SR-34 in Bulls Gap 0.3 miles south of Speedwell Road/Old Highway 66) [Hawkins County]: \$32.4 million
- I-81 (eastbound truck climbing lane at Mile Marker 60) [Sullivan County]: \$27.28 million
- SR-126 (East Center Street in Kingsport to east of Cooks Valley Road) [Sullivan County]: \$48.6 million
- SR-93 (from south of Horse Creek to north of Derby Drive) [Sullivan County]: \$6.3 million
- I-26 (interchange modification at SR-354) [Washington County]: \$12.8 million

- I-26 (constructing auxiliary lane and widening eastbound I-26 travel lane, interchange at SR-67 [US-321]) [Washington County]: \$2.6 million
- SR-93 (from north of Davis Road to north of Fire Hall Road) [Washington County]: \$3.4 million
- SR-93 (from Morgan Lane in Washington County to south of Baileyton Road in Sullivan County) [Washington and Sullivan counties]: \$5 million

“This is another key piece of information about how important it is to invest in our transportation infrastructure and how current funding is not meeting the need. The list of backlogged projects – many of which cross multiple counties – comes on the heels of an economic impact study showing how increased investment in transportation would create thousands of new jobs and would generate millions of dollars in new economic activity.”

SUBJECT: Backlog Projects

Dear Chairman Matlock:

In the March 3, 2015, House Transportation Committee, it was requested that the Department of Transportation provide the Committee with a listing of "backlog" projects. We use the term "backlog" to refer to the unfunded phases of project commitments made in prior years as part of its annual budget approval by the General Assembly.

The Department submits a listing of programs and projects (the Legislative Program) in support of its annual budget prior to the General Assembly passing the state budget.

Project commitments are made based on programmatic assignment of funds and through specific projects, both identified in the Legislative Program.

Programmatic assignments consist of projects necessary to maintain the existing transportation system in a state of good repair including bridge rehabilitation & replacement and resurfacing projects and projects developed through specialized funding availability such as safety, air quality, and non-traditional mode programs.

Specific projects in the Legislative Program are identified and developed in three phases, Preliminary Engineering (PE), Right of Way acquisition (ROW), and Construction (Const). Once a project is listed for PE in the Legislative Program, it is considered a commitment on behalf of the Department to see the project through its final delivery.

The Department is evaluating specific projects in the backlog to find opportunities for utilizing our Expedited Project Delivery (EPD) concept to reduce overall project cost while addressing the transportation need and accelerating their delivery. Please note that a no-build alternative may be the final outcome of a project under federal rules, although it is rare.

Projects cannot be cancelled without notification of the General Assembly and where federal funds are involved, cancelation may require the repayment of federal funds.

Since it does take several years to design a project, acquire the real estate, and receive the appropriate approvals to build a project, some level of backlog is necessary to establish an efficient mechanism of deliver projects. The Department estimates that a backlog of approximately 8 times our annual funding for the specific projects in our Legislative Program is appropriate. We currently have approximately \$500 million in annual funding available to address these specific project commitments. Based on an 8 year delivery cycle, this would generate an appropriate backlog level of about \$4 billion.

The enclosed list of projects consists of 254 specific project phases totaling \$6,132,023,692 and represents the Department's current commitments or backlog. Inflationary costs in the mid to late 2000's grew our backlog workload to its current level and the Department has only included a modest number of new commitments since that time. Please note that these are only estimated costs based on the best available information on each specific project.
